**Subject: Corrigendum -1 of e-tender No.- 2025\_SSRG\_418690\_1**

This is with reference to the Pre-Bid Meeting held on 29.04.2025 at 12:00 PM at the Conference Hall, Ground Floor, SSR GSP, concerning the tender for the Selection of Agency for Hostel Mess and Catering Services.

During the meeting & site visit, several queries and suggestions were raised by the vendors participating in the session. After due consideration, the following amendments and clarifications are hereby issued. These shall be treated as part of the tender document and are binding on all bidders:

1. SSRGSP shall make compulsory for all trainees residing in the hostels to avail mess facility (as far as possible) so as to ensure continuous and smooth operations.
2. Payment for mess services by trainees shall preferably be **made online through UPI or Net Banking**, however all the vendors are informed that they have to deal directly with the students / trainees.
3. Considering that the financial documents for FY 2024-2025 will be available only by September 2025, the **financial eligibility shall be based on FY 2021-2022, 2022-2023, and 2023-2024.**
4. It is already mentioned in **Annexure 5.1, Point No. 1.3** of the tender document that a Chartered Accountant's Certificate with UDIN is acceptable for certifying the turnover of the last three financial years.
5. **A security deposit equivalent to 02 months** of mess charges shall be collected by the SSR GSP from the trainees who are availing hostel facilities or mess facilities, and the same shall be refundable / adjusted after completion of the course.
6. Any rebate or reduction in mess charges for trainees availing mess facilities, if introduced in the future by the State Government, shall be borne by the SSR GSP.
7. In Part-B, Item No. 24 of the BoQ (Water Dispenser – Bisleri or equivalent, 20L water jar with dispenser), the rate includes the cost of the 20L water jar along with the dispenser. However, for the purpose of refilling the 20L water jar, separate rates are required. Accordingly, one additional item, i.e., Item No. 25, 20L Water Jar (Cold/Normal) Bisleri or equivalent has been added to the BoQ. The revised BoQ is enclosed and has also been uploaded on the MPTender portal
8. In the Notice Inviting Tender (NIT), Point No. 1, the date mentioned as "01/05/2025" should be read as "07/05/2025."

All interested bidders are requested to take note of the above amendments. This corrigendum shall form an integral part of the tender document.
