#### Part – A: Empanelment of Hospitals

#### **Issued By:**

Sant Shiromani Ravidas Global Skill Park, Bhopal (Department of Technical Education, Skill Development & Employment, Government of Madhya Pradesh)

**Subject:** Invitation for Empanelment of Hospitals and Diagnostic for Providing Medical Services.

Sant Shiromani Ravidas Global Skill Park, Bhopal, invites Expression of Interest (EOI) from licensed and qualified hospitals and diagnostic centre located within a 2 km radius of the institute for empanelment to provide 24x7 emergency and general medical services to students.

## **Eligibility Criteria:**

- The hospital must be located within a 2 km radius of the institute.
- Must possess all necessary licenses and approvals to operate as a medical institution.
- Must be equipped with adequate infrastructure, including emergency care, outpatient department (OPD) services, ICU, Operation theatre and qualified medical and paramedical staff.
- Preference will be given to hospitals offering concessional rates for students/staff.

#### **Scope of Services:**

- 24x7 emergency medical care
- Outpatient services
- General medical treatment
- Referral services where necessary

**Submission Requirements:** Interested hospitals are required to submit the following documents:

- Cover letter expressing interest in empanelment
- Copy of valid registration/license to operate
- Details of available infrastructure and services
- List of medical and paramedical staff
- Details of emergency care facilities
- Consent to provide student concessions (if applicable)
- Any additional information supporting the application
- Copy of PAN, GST, and other applicable tax registrations
- Applicable certificate from regulated authorities like NABH.

#### Part - B: Empanelment of Diagnostic Centre

#### **Scope of Work**

Empaneled diagnostic centers shall be required to provide services that may include, but are not limited to:

- Pathology Tests (Biochemistry, Hematology, Microbiology, etc.)
- Radiology and Imaging Services (X-ray, MRI, CT scan, Ultrasound, etc.)
- Home Sample Collection (if applicable)
- · Reporting and documentation as per medical guidelines
- Timely communication of reports to patients and the Authority

Eligibility Criteria: Diagnostic centres must meet the following eligibility criteria:

- Must be registered under applicable laws (e.g., Clinical Establishment Act)
- Valid license from appropriate regulatory authority
- Minimum [X] years of experience in diagnostic services
- NABL/NABH accreditation preferred (mandatory for certain categories)
- Availability of qualified medical and technical staff
- Infrastructure to support digital reporting and data sharing

### **Documents Required**

Interested parties must submit the following documents along with the EOI:

- Cover Letter expressing interest
- Company Profile and ownership details
- Certificate of Registration / License
- Accreditation Certificates (if any)
- Details of services offered and price list
- Details of staff, equipment, and infrastructure
- Copy of PAN, GST, and other applicable tax registrations
- List of clients/affiliated hospitals (if any)
- Undertaking for compliance with data privacy and medical ethics
- Applicable certificate from regulated authorities like NABL/NABH accreditation.

## **Evaluation and Empanelment Process**

- All EOIs will be evaluated based on eligibility, infrastructure, capability, pricing, and past performance.
- Shortlisted diagnostic centers will be invited for technical and financial discussions if needed
- The empanelment shall be valid for a period of [1/2/3] years, extendable based on performance.
