All Corrigendum's/ Amendments/ Corrections, if any to this EOI will be published only on https://globalskillspark.in/ OR the Institute website and the bidder(s) is / are advised to keep visiting the institute's website regularly for updates/ changes.
- (b) The EOI document should be prepared in given format only, along with commercial terms and conditions and supporting documents.
- (c) The bidders may seek detailed clarifications on the conditions of bidding document as per the schedule mentioned in Table 1.
- (d) The Institute expects the bidders to comply with the EOI specifications/ conditions, which shall be within due date. The bid not complying with the terms and conditions of the EOI document and offers indicating any exception/ deviation shall be liable to be rejected.
- (e) The bid must be dropped in the Tender Box at the Account office of SSR GSP Bhopal asper the timings mentioned in Table 1.
- (f) The bidder intending to send their offers by post may send the same under registered cover/ courier or by hand delivery so as to reach the designated place well before closing date and time. However, the Institute accepts no responsibility for offers received after the due time and date. Also, all envelopes should be marked in bold "Expression of interest (EOI) for empanelment to provide hotel accommodation for SSR GSP ".
- (g) The bidder is expected to examine all instructions, forms, terms & specifications in the bidding documents. Failure to furnish all information required by the bidding documents will be at the bidder's risk. The bid not complying with EOI conditions and not conforming to EOI specifications will result in the rejection of its bid without seeking any clarifications.
- (h) No separate information shall be given to the individual bidders.
- (i) The EOI documents duly signed & stamped as a mark of your acceptance will be submitted.
- (i) No bid will be entertained by E-mail/Fax.
- (k) Bid submitted by the bidder would be examined and their premises would be inspected by the expert committee constituted by the institute.
- (l) The Institute reserves the right to accept or reject any bid and to annul the bidding process and reject all bids at any time prior to empanelment, without thereby incurring any liability to the affected bidder or bidders or any obligation to inform the affected bidder.
- (m) Incomplete/ Conditional bid will be rejected without consideration.
- (n) The Institute reserves the rights to cancel the EOI without any reason thereof.
- (o) In the event of any dispute or difference(s) between the Institute and the bidder arising outof non-compliance of EOI terms and conditions or any other cause whatsoever relating to the EOI shall be referred to the CEO of the Institute, whose decision shall be final and binding on both the parties.
- (p) All disputes shall be subject to the Civil Court Jurisdiction of Bhopal MP Only.

Accommodation Types and Room Requirements

1. Room Categories:

- Deluxe Single Rooms. (@1500 Rs / 24 hrs.)
- Deluxe Double occupancy Room. (@2500 Rs /24 hrs.)

2. Amenities:

- Wi-Fi access, air-conditioning/heating, hot water and access to 24-hours room service.
- Rooms should be cleaned daily, with fresh linens and toiletries provided.
- Facilities and Services

3. Dining Options:

- Complimentary breakfast included.
- Availability of options for lunch and dinner.

4. Laundry Services:

• Laundry and ironing services should be available at reasonable rates.

5. Transportation

• To and fro from offered premises / hotel to SSRGSP Hazrat, Nizamuddin Rd, NarelaShankari, Sector B, Indrapuri, Bhopal,

6. Health and Safety Compliance.

- The hotel should have certifications for hygiene and safety standards including fire safety.
- Emergency contact and medical assistance details should be readily available.

7. Duration of Stay

 Tentative timeline based on requirements, with an initial estimate for per night rates for each room category. Flexibility in check-in/check-out timing to accommodate early arrivals and late departures would be beneficial.

9. Additional Requirements

- Preference for hotels within a 12 km radius of the SSRGSP.
- Availability of secure on-site parking facilities if needed.

3. General Terms & Conditions: -

- (a) The empanelment of hotel is for a period of One year and extendable to another 01 year basis.
- (b) The empanelment can be done with one or more bidders as per the selection criteria and at the sole discretion of the Institute.
- (c) Chief Executive Officer, Sant Shiromani Ravidas Global skills Park (SSR GSP) Bhopal reserves right to terminate agreement without any reason at any time, giving notice of One month.
- (d) Payment towards the monthly rental of the occupied rooms will be Assured by the SSRGSP Administration.
