Subject: Corrigendum -2 of e-tender No.- 2025_SSRG_422572_1

This is with reference to the Pre-Bid Meeting held on 19.05.2025 at 12:00 PM at the Conference Hall, Ground Floor, SSR GSP, concerning the tender for the Selection & Hiring of Agency for Housekeeping & Security Services is SSR Global Skills Park.

The information regarding Corrigendum-1 was shared with the bidders present during the meeting.

During the meeting & site visit, several queries and suggestions were raised by the vendors participating in the session. After due consideration, the following amendments and clarifications are hereby issued. These shall be treated as part of the tender document and are binding on all bidders:

1. Page No. 5 - Section I: Notice Inviting Tender (NIT) - Schedule - EMD (Earnest Money Deposit):

To claim exemption from submitting Earnest Money Deposit (EMD) in compliance to Clause 14.1 of the Madhya Pradesh Store Purchase Rules (MPSPR), bidders must furnish documentary proof like valid and latest Udyam Registration Certificate.

Bidders were informed during the Pre-Bid Meeting that exemption from EMD is strictly governed by Clause 14.1 of the MPSPR and the same has been clearly mentioned in the NIT.

2. Page No. 10 - Clause 12.2 (I): Housekeeping and Security Services The term "Housekeeping and Security Services" shall be interpreted as applicable both in combined form and separately throughout the tender document.

Further, the requirement of ISO 9001 certification shall be considered valid whether services are offered jointly or individually.

3. Page No. 11 - Clause 13.3(a): Bid Security

To be read as:

"A bank guarantee issued by a Nationalized Bank or Private Bank (approved by RBI), in the format provided in the bidding documents, and valid for a period of 45 (forty-five) days beyond the bid validity period (as specified in Section X)."

4. Page No. 15 - Clause 23.5(1): Point 4 - Clientele Base - Technical Evaluation Criteria: To be read as:

"Bidder must have provided services to a minimum of three (03) different entities from either Government, PSU, or reputed Private Sector (State/Central). Out of these, at least two (02) clients must be a Government entity."

5. Page No. 22 - Clause 11.2: Prices

To be read as:

"The Service Charges (Sr. No. 02 of Price Schedule) quoted by the bidder shall include all overheads such as administrative charges, machinery costs, supervision, transportation, and any other incidental expenses.

This excludes the cost of manpower (Sr. No. 01) and material charges (Sr. No. 03), which are to be quoted separately.

Important Note: Service Charges must not be quoted below 10%. This is in compliance with the Madhya Pradesh Finance Department Order No. F11-1/2023/Rule/Four, Bhopal, dated 31.03.2023, which states:

- (अ) कर्मियों के लिए श्रमायुक्त द्वारा नियत पारिश्रमिक
- (ब) वैधानिक देयताएँ ईपीएफ, ईएसआई इत्यादि
- (स) एजेंसी के प्रबंधकीय शुल्क (अ का 10%)|"

Bids quoting less than 10% service charges shall be rejected and not considered for financial evaluation.

- 6. Page No. 34 Section F: Tentative Requirement of Manpower/Month SN 9 Electricians: "To be considered as "Highly Skilled Workers" for the purpose of this tender. Accordingly, Section IX (Price Schedule) on Page No. 42 stands revised and attached with this corrigendum."
- 7. Page No. 42 Section IX: Price Schedule / Bid Format Point(g):

"In case the Madhya Pradesh e-Tender Portal fails to generate the correct L1 bidder due to technical or logical limitations, SSR GSP reserves the right to compute the L1 bidder independently based on the tender conditions and declare the same."

Additional Provisions:

1. Waste Management [New Clause]

The selected agency shall be responsible for the collection, segregation, and disposal of waste strictly as per prevailing Government and Municipal Corporation guidelines.

- Waste shall be segregated into the following categories:
 - o Dry Waste
 - o Wet Waste
 - Used Oil
 - Metal Chips
 - o Oil-Soaked Rugs
 - o Electrical and Electronic Waste

The agency must ensure that the segregated waste is deposited at the designated pickup point for timely collection by the Municipal Corporation.

2. Hygiene Maintenance [New Clause]

It shall be the full responsibility of the agency to maintain cleanliness and hygiene across the entire campus premises, including but not limited to restrooms, offices, common areas, and outdoor surroundings. Regular monitoring and compliance with hygiene standards shall be ensured.

3 Section IV Point - p [New Clause]

Cleaning of underground water storage tanks and overhead tanks – Concrete and PVC should be clean on regular basis.
