Subject: Corrigendum – 1 to the e-Tender No. 2025\_SSRG\_434576\_1 for Procurement of Stationery and Miscellaneous Items

With reference to the above tender, based on the queries received and the institute's requirements, the following amendments and clarifications are hereby issued. These shall form an integral part of the tender document and are binding on all bidders:

## 1. Supply of Mentioned Makes/Brands

It is clarified that for any item where makes/brands have been mentioned in the tender document, the bidder is bound to supply the brand as required by the institute and cannot deny the supply of items of the specified make/brand.

**Important:** If the bidder fails to supply the item of the desired make/brand at the quoted rate, the agreement shall stand **cancelled with immediate effect**, and the institute reserves the right to take appropriate legal and administrative action, including forfeiture of the performance security.

- **34.** "Bidders are hereby instructed to submit the Revised Bill of Quantities (BoQ) enclosed with this corrigendum. Failure to submit the revised BoQ shall result in disqualification of the bidder from the tender evaluation process at the sole discretion of SSR GSP."
- **35.** "Bidders must submit their offers strictly through the e-procurement portal of the Government of Madhya Pradesh (https://mptenders.gov.in) in the prescribed format".
- **36.** "The competent authority reserves the right to place order either of all the items or only some of the items. The supplier shall have no right to claim any compensation in such case."
